UPDATE FROM ARTISTIC DIRECTOR

6:52 pm

- BST presented *Volpone* in post-dictator Myanmar in January. Read more about the project.
- Upcoming grants (submitted & proposed): State Department and Foundations (list provided).
- Upcoming project: working with refugees in Malaysia, sponsored by Rational Games.
- Guest at a SEALA (Southeast Asian Leadership Academy) event in Bangkok, and will be teaching at the global Leadership Academy event in Vienna in the fall.
- Current project in Afghanistan: focus on justice and rule of law funded by USIP. Questions about BST Afghan staff (Mariam Kosha, Sita Osmany, Sayed Karim Zhwandoon): staff funded since Oct. 2014; NYC-Afghanistan communication maintained daily via email.

UPDATE FROM MANAGING DIRECTOR

7:05 pm

- Balance sheet: In a slightly better position than last year, with unrestricted funds available in addition to funds restricted for upcoming programs.
- BST will not be getting full audit because budget is under \$750,000 federal audit minimum.
- Discussion re: percentages for Program vs Administration. Consensus that anything over 70% toward programs is fine, and raising administrative costs suggests stability and sustainability.
- Discussion re: building donor base. Longtime donors can be asked to help close a percentage gap in overhead (ie, moving from 13% to 15%). Alice suggests that post-retirement women and widows (60+) looking for renewed purpose in their lives can get involved with BST through donations and/or travel with BST, and she works with many in this position.

MAIN TOPIC: STRATEGIC PLANNING – Discussion of Initial Steps

7:28 pm

- Develop a picture of the organization. Highlight the universal values that make BST so popular abroad in BST's domestic marketing approach.
- Value of an Outside Facilitator. Consensus to bring in an expert with knowledge of field but not with BST directly. Facilitator should understand the target market, and diverse enough experience to help the organization break out of its silo. Also best to find a facilitator familiar with organizations of a similar size.
- Value of a Board Retreat one day or longer. A retreat will help to clarify BST's mission and programming among all Board members, leverage Board engagement, and create a viable mission-based plan to move the company forward.
- Stressed need for clear Objectives, Targets and Dates, to measure progress toward goals and objectives. Include contingency planning.
- Alice offers to underwrite cost of space for a Board retreat in NYC.
- Dates: Weekday preferable. Primary: Tuesday, June 13th. Alternate: Tuesday, July 11th

DISCUSSION OF PREVIOUS STRATEGIC PLANNING EFFORTS

- Previous efforts resulted in extra work for staff.
- Suggestion that Board members write their own view of BST *vision* and *mission* in advance of retreat. For additional info, BST website has complete organizational picture.
- The Strategic Plan replaces the annual Board Initiatives, which were goals without a strategy to achieve them. Goals will be organizational in scope and prioritized based on the mission.

- The future of State Department and USIP funding, the mainstay of BST funding.
- Need to find new foundation support. Nadia emphasizes need for a strong fit between goals of foundations and BST. If it's not there, not worth an application.
